MINUTES-

A. CALL TO ORDER

Chairman John M. Sharp called the meeting to order at 10:07 a.m. He introduced himself and entertained introductions of members, staff, and guests. There was a quorum.

B. APPROVAL OF THE MAY 11, 2023 MINUTES

David Riesland moved to approve the May 11, 2023 minutes. Mayor Terry Arps seconded the motion. The motion carried unanimously.

C. ACTION ITEMS:

1. Proposed Final FY 2024 Unified Planning Work Program (UPWP) for the ACOG MPO Area

Jennifer Sebesta highlighted the information as detailed in the agenda memorandum. She also noted that there are tasks related to the 2050 Plan development, federal grants that ACOG manages, and projects that have already been selected that are monitored, the Regional Air Quality Plan, the Safe Streets and Roads for All (SS4A) grant that was received, the Climate Pollution Reduction Grant (CPRG) that ACOG anticipates receiving, and updates as far as the current Plan.

Robert Floyd moved to recommend that the ACOG MPO Policy Committee approve the proposed final FY 2024 ACOG MPO Unified Planning Work Program and authorize staff to proceed with executing related contracts and agreements, subject to availability of funds. David Riesland seconded the motion. The motion carried unanimously.

2. Amendments to the FFY 2022-2025 Transportation Improvement Program

Jennifer Sebesta said this is a TIP amendment requested by the Central Oklahoma Transportation and Parking Authority to program federal funds that they received. She then gave the details of what COTPA wants to do with those funds, as detailed in the agenda memorandum.

Mayor Terry Arps asked about the ferryboat – where does it start, end, and what does it serve. Chip Nolen said the ferryboat service operates on the Oklahoma River, with a number of ferryboat landings at Exchange Avenue, Bricktown, Regatta Park, the Stockyards, and Meridian Avenue. They offer public transportation and also have some charters. Mayor Arps asked if the ferryboat is primarily for transportation or recreation tourists. Mr. Nolen said it was a combination.

Ms. Sebesta said if approved, this amendment will be sent to ODOT to be included in the STIP, and then will go to FHWA and FTA for final approval.

Justin Henry moved to recommend that the ACOG MPO Policy Committee amend the FFY 2022-2025 Transportation Improvement Program by updating the COTPA FFY 2023 Transit Element with the attached program of projects and submitting the same to the Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP). David Riesland seconded the motion. The motion carried unanimously.

D. ITEMS FOR INFORMATION ONLY:

1. 2023 Bike Month Recap

Mayor Arps said the one area where he is a fan of electric bicycles is for the elderly who might need a little power boost getting to and from where they want to go without having to drive a car. He asked if electric bicycles use bike lanes. Ms. Nolen said yes. He also asked about the bike trails – can electric bikes use those. Ms. Nolen said it depends upon the city. Mr. Sharp said some trails have speed limits. Jose Jimenez said there are Classes 1, 2, and 3 electric bikes. Class 1 is electric assist up to 20 mph, Class 2 goes up to 25 mph, and Class 3 goes up to 28 mph. He said there are some rules for certain classes of electric bikes on multi-use trails. Mayor Arps asked who would enforce the rules and Mr. Jimenez said the municipalities. Mayor Arps asked if the Route 66 shoulders are considered routes for bicycles. Mr. Sharp said on Route 66 in Oklahoma County, ODOT has some portions where they will have extended the width of the shoulders to allow safer access for cyclists to give everybody a little space. Also, if there is a five-foot shoulder, that helps from the standpoint of road maintenance.

2. 2022 Bicyclist and Pedestrian Counts Presentation

Chairman Sharp said traffic counts are also collected for vehicles on roads and ACOG's website carries that information, along with the bike/ped counts. He said for the bike/ped projects funded through TAP, ACOG strongly suggests having a counter installed as part of the project so that data can continue to be gathered.

3. Quarterly Transit Coordination Meeting Update

Hannah Nolen said the last Quarterly Transit Coordination Meeting was hosted by Norman Transit and said Jason Huff would provide a brief summary about what was discussed at the meeting.

Mr. Huff said those attending included Edmond, Oklahoma City Planning, EMBARK, and Norman Transit. At the meeting, Norman Transit discussed route changes currently going on in Norman, noting that in 2019, they took over the transit operations from the University of Oklahoma, working with FTA and their partners to get that taken care of. One of the first items they were tasked with when taking over the service was updating their long-range plan, which was completed in 2021. He said the first recommendation in the plan was to re-work their routes that had been in effect since the 1980s. Norman Transit is now making the routes bi-directional, which is more user friendly and that will start October 1 – adding about 50 bus stops and taking away about 50 bus stops. They held a public comment period, and are now issuing a Request for Proposals (RFP) to construct all those bus stops.

The City of Norman bought property at an old Chase Bank location, at 320 E Comanche St., which will become the new transit center.

Mr. Huff said the next Quarterly Transit Coordination meeting will be hosted by EMBARK at 2 p.m. Wednesday, September 6, 2023.

4. Air Quality Small Grant Program Call for Projects

5. Clean Air for Public Sector Fleet Grant Call for Projects

David Frick said this Call for Projects (CFP) is similar to the Air Quality Small Grant Program, with the CFP opening August 1, 2023 and applications due September 29, 2023. He said this grant is about upgrading and converting public fleets to clean alternative fuel vehicles that includes electric, hydrogen, Compressed Natural Gas (CNG), and propane. This year off-road vehicles are also included, such as, forklifts and lawn equipment. Since there is approximately \$4 million to distribute, they also want bigger projects, so Mr. Frick suggested charging infrastructure and alternative fuel stations.

Jaclyn Todd asked if this would cover the full cost of a new alternative fuel vehicle and Mr. Frick said it is an 80 percent federal/20 percent local match of the full cost. Mayor Arps asked if schools can apply and Mr. Sharp said yes.

6. ACOG MPO Transportation Management Area Line Item Projects and Administrative Modifications

Lauren Wood said this month, there was one new line item project from ODOT and one new administrative modification from ODOT. She said those items can be viewed in the agenda.

7. Projects in the ACOG MPO Transportation Management Area (TMA)

John Sharp said the committee members could click on the links to see the progress of their projects. He announced that there will probably be another quarterly discussion about the projects in August. Mayor Arps asked when TAP projects could be applied for. Matt VanAuken said ODOT will begin its next TAP Call for Projects in January 2024.

E. NEW BUSINESS

Chairman Sharp asked if there was any new business to present.

New Clean Cities Summer Intern

Eric Pollard announced that Judith Anima Ntim is ACOG's new Clean Cities Summer Intern. He said she is a graduate student pursuing her master's degree in Regional and City Planning at the University of Oklahoma, where she is a graduate research assistant. She will be at ACOG through mid-August, and maybe longer.

STBG Subcommittee Meeting

Jennifer Sebesta said that she and John Sharp met with ODOT staff this last month to discuss the STBG program. ODOT has a fourth-quarter distribution that allows additional money to come to the region if projects are ready. The ACOG projects have not been ready the last couple of times, so ACOG was not able to take advantage of the extra funding.

ODOT had some suggestions on how to make our program more efficient, which will be discussed at the STBG Subcommittee meeting scheduled for Tuesday, June 27, at 10 a.m.

Streetlight Data

Mr. Sharp said ACOG has gone into contract with StreetLight for \$371,815 in order to update the Travel Demand Model, which has not been done in about 12 years. ACOG needed better origin and destination information and bike/pedestrian information, and with the help of the transit agencies, a transit portion will be added to the model. There is traffic count data available with the StreetLight Data that will be tested to see if it is comparable to the data collected by some of ACOG's member cities. It might also help ACOG collect data from smaller communities.

Possible Additional Grant Funding Available

Mr. Sharp provided a handout called "<u>Combined Notice of Funding Opportunity (NOFO)</u>: <u>Reconnecting Communities Pilot and Neighborhood Access and Equity Programs</u>." He said this offers possible additional funding for projects in the communities.

There being no further business, Mr. Sharp adjourned the meeting at 11:09 a.m.

MODIFICATIONS TO THE SURFACE TRANSPORTATION BLOCK GRANT -URBANIZED AREA (STBG - UZA) PROJECT SCORING CRITERIA AND PROCEDURES

INFORMATION:

On June 28 and July 20, the STBG-UZA Subcommittee met to discuss potential changes or updates to the criteria and STBG-UZA program procedures. The following changes were suggested by subcommittee members.

Suggested Procedures Changes:

- Increase the number of locked years to two for the FY 2024 Call for Projects cycle. ACOG MPO member communities (excluding El Reno) may submit projects for FFY 2026 and FFY 2027 funding. ACOG staff will assign a year to the selected projects based on the availability of funds, ODOT Local Government staff recommendations, and the principles outlined in the STBG-UZA program procedures document.
- 2. Include project design and engineering as an allowable expense under the STBG-UZA program. ACOG MPO member communities may include design and engineering as part of the itemized cost estimate submitted for each project. The itemized cost estimate needs to be signed, stamped, and prepared by a registered professional engineer licensed in the State of Oklahoma, and must be dated within 6 months of the upcoming CFP submission deadline. ACOG member communities may also include costs for the negotiation of right-of-way, but the costs associated with the purchase right-of-way, as well as utility relocation are not eligible; they are the responsibility of the sponsoring entity. Design and engineering costs must be clearly defined in the itemized estimate and ACOG reserves the right to adjust the design and engineering cost amount based on ODOT Local Government staff recommendations.
- 3. Allow for the over programming of STBG-UZA funded projects, in coordination with ODOT and with approval by FHWA. ACOG staff will select projects in excess of the STBG-UZA yearly apportionment for the ACOG MPO area. Please note that funding for 100 percent safety projects will be limited to 10 percent of the original apportionment amount per federal fiscal year.

Suggested Criteria Changes:

4. *Regarding Criterion C6. Does this project provide benefits for multiple communities or leverage other investments?*

Limit the projects that can receive points to joint projects between two or more ACOG member entities (city/city, city/county, city/ODOT, county/ODOT), projects that border another ACOG member entity, or projects that end at the boundary of another ACOG member entity. Phased projects and projects with other entities (i.e. schools) will no longer receive points for this criterion.

5. Projects with 60 percent design or greater may receive an additional 5 points. Documentation demonstrating that design is at 60 percent or greater must be submitted before the close of the Call for Projects cycle. Supporting documents will be reviewed by ODOT Local Government staff for verification before a project can receive points.

Any approved modifications will be incorporated into the STBG-UZA Procedures and STBG UZA Scoring Criteria for consistency between the documents. The updated procedures and criteria will be in effect during the upcoming Call for Projects and the updated documents will be posted to the <u>STBG-UZA Project Scoring Criteria Dashboard</u> prior to the open of the Call for Projects.

INFORMATION:

Performance-based planning and programming has become a national emphasis per recent federal transportation legislation—namely, the 2012 Moving Ahead for Progress in the 21st Century (MAP-21) Act, 2015 Fixing America's Surface Transportation (FAST) Act, and 2021 Infrastructure Investment and Jobs Act (IIJA). Federal planning requirements direct metropolitan planning organizations (MPOs) to coordinate with their respective state department of transportation and area public transportation providers in developing 14 performance measures and targets to track and maximize the benefits of transportation planning decisions and infrastructure investments. Five of the performance measures focus on safety and targets are developed annually. The ACOG MPO Policy Committee last approved safety targets in March 2023. The remaining nine performance measures deal with system performance, bridge, and pavement condition and targets are developed every four years.

Recently, the Oklahoma Department of Transportation (ODOT) submitted the nine required system performance, bridge, and pavement condition performance measure targets to the Federal Highway Administration (FHWA). Now, ACOG as an MPO, must identify and submit its regional targets for those same nine performance measures. Federal guidance states that MPOs may either support the targets of the state or may submit their own targets based on the data from the ACOG MPO area. In either instance, ACOG will need to report on the measures and the targets, and eventually explain how its region is making progress towards reaching those targets. This occurs through both the short-range plan (TIP) and the Metropolitan Transportation Plan (MTP). In particular, projects should be selected using criteria which help support the goals, measures, and targets established by the ACOG MPO area in the MTP.

After analysis, ACOG's recommendation is to support the ODOT targets, as identified in <u>Table 1</u>.

ACTION REQUESTED:

Consider recommending that the ACOG MPO Policy Committee approve the recommendation of supporting ODOT's system performance, bridge, and pavement condition performance measure targets as the targets for the ACOG MPO area.

INFORMATION:

The FTA Enhanced Mobility of Seniors and Individuals with Disabilities formula funding, Section 5310, is provided to states and designated recipients to meet the transportation needs of older adults and people with disabilities. MPOs, states, and other public agencies are eligible to be the direct recipient of Section 5310 programs in urbanized areas larger than 200,000 in population. Currently, the only 5310 designated recipients in the State of Oklahoma are ODOT and INCOG. ODOT manages the 5310 funds for all of Central Oklahoma.

The Central Oklahoma Transportation and Parking Authority (COTPA) is requesting to become the designated recipient of the 5310 Program in the urbanized area. As the designated recipient, COTPA would be responsible for administering Section 5310 Program funds, complying with program rules and requirements, and overseeing any subrecipients COTPA chooses to receive and expend these funds.

ACOG supports and recommends that COTPA be designated as the FTA Section 5310 designee for the Urbanized Area. A resolution will be signed by all parties concerned upon approval by the ACOG MPO Policy Committee.

Consider recommending that the ACOG MPO Policy Committee adopt a resolution to recommend that the Central Oklahoma Transportation and Parking Authority (COTPA) be a designated recipient of the FTA Section 5310 Program and its funds be apportioned to the Urbanized Area.

ACOG staff have completed the preliminary FFY 2024-2027 ACOG MPO Transportation Improvement Program (TIP) based on input from ACOG MPO local governments, the Oklahoma Department of Transportation (ODOT), the Central Oklahoma Transportation and Parking Authority (COTPA), Norman Transit, the Oklahoma City Department of Airports, and other area airport operators.

The TIP identifies all federally funded surface transportation projects expected to be carried out by city, county, state, and local transportation agencies during federal fiscal years 2024-2027. This includes upcoming state-sponsored projects within the ACOG MPO area, under the jurisdiction of ODOT, upcoming transit projects provided by COTPA and Norman Transit, and proposed airport improvements provided by local airport operators.

Opportunity for public review and comment on the preliminary FFY 2024-2027 TIP was announced by public notice in The Oklahoman, a news release distributed to metro area media outlets, and on ACOG's website and social media suite.

Committee members are requested to review the preliminary TIP (available on the ACOG website) and provide any written comments to ACOG at <u>TIP@acogok.org</u>. Comments received by 4 p.m., Tuesday, August 29, 2023, will be forwarded to the ACOG MPO Policy Committee for review during its August 31 meeting.

The final document will be provided to the Technical and Policy Committees in September and submitted to ODOT for approval and inclusion in the Statewide Transportation Improvement Program (STIP). The TIP will become effective at the start of the federal fiscal year on October 1, 2023.

INFORMATION:

To ensure that the Surface Transportation Block Grant Program for the Urbanized Area (STBG-UZA) continues to reflect local government priorities that meet federal requirements for authorization, ACOG is inviting each community within the ACOG MPO boundary to submit projects for funding consideration.

If your entity wishes to submit a project or projects, the following information needs to be submitted to ACOG no later than **4 p.m., Monday, October 31, 2023.**

- **ProjectTracker (formerly eTRACKER) application form** for each project, which identifies the proposed funding source(s) and amount(s). Applications submitted during the last Call for Projects (and therefore have an application already created) will be open for editing.
- **STBG-UZA Programming Resolution** (with original signatures or a certified copy), adopted at a public meeting of its governing body, which describes the location of the project, type of improvement, total project cost, and source(s) of funds (a sample format is available from ACOG).
- Itemized cost estimate for each project submitted, signed, stamped, and prepared by a registered professional engineer licensed in the State of Oklahoma. Cost estimates must be dated within 6 months of the upcoming CFP submission deadline. Costs associated with right-of-way acquisition and utility relocation are not eligible; they are the responsibility of the sponsoring entity.
- Map of each proposed project showing its location, termini, street name(s), north arrow, and the names of nearby major streets. Projects may be mapped in or uploaded to ProjectTracker.
- The appropriate **Project Rating Worksheet(s)** for each application requesting STBG-UZA funds. Projects with multiple aspects, such as a widening with intersection improvements or resurfacing with bicycle facilities, are required to have a completed Project Rating Worksheet for each component.
- **ODOT Project Scoping Form** for each project.
- Any supporting documentation listed in the STBG-UZA Application Guidebook that supports the project score on the Project Rating Worksheet(s).

In order to be eligible for STBG-UZA funding, all prospective applicants must fill out a pre-application form for each project. The pre-application form will be available beginning August 21, 2023, and will close on September 15, 2023. This will allow ACOG staff time to review projects and discuss potential revisions with the applicant before beginning the full application

process. A completed CY 2022 Network Monitoring Survey must be submitted by the Call for Projects deadline in order to be considered for funding. The CY 2022 Network Monitoring Survey is available for download here: <u>Network Monitoring Survey CY 2022 (excel file)</u>.

As a reminder, each STBG-UZA project selected for a locked year must be programmed through ACOG and ODOT, and all proposed federal-aid projects (except bridges) must be located on the approved Federal Functional Classification System for the Oklahoma City Urban Area. Construction projects on the State Highway System (interstates, U.S. highways, and state highways) are not eligible for funding.

Selected projects will be included in the FFY 2024-2027 ACOG MPO TIP. It should be noted that inclusion of a project in the TIP does not represent a commitment of federal funds. The actual obligation of federal funds is contingent upon processing of all federal requirements, including environmental clearance; right-of-way acquisition; right-of-way, utility and encroachment clearance; completion of right-of-way and design plans; deposit of local matching funds with the Oklahoma Department of Transportation; and availability of federal funds. Additionally, all project funds are capped at the cost estimate plus contingencies and inflation. Any cost overages will be borne by the sponsoring entity.

It is strongly encouraged for prospective applicants to schedule project coordination meetings with ACOG staff before or during the Call for Projects period to discuss projects and address any questions. Please contact ACOG at (405) 234 2264 or at TPSgrants@acogok.org to schedule a meeting.

2020 CENSUS DEFINITIONS AND ITS IMPACT ON THE URBANIZED AREA BOUNDARY

INFORMATION:

Following each decennial census, the U.S. Census Bureau designates "urban areas" for statistical purposes. A list of the 2020 urban areas can be found in the December 29, 2022 Federal Register. The Federal Highway Administration (FHWA) uses the term "urbanized area" to mean an area with a population of 50,000 or more designated by the Census Bureau.

These are the following FHWA programs that are impacted by the urbanized area boundary (at the state level):

- Highway Functional Classification (Urban/Rural)
- HPMS Reporting
- Critical Freight Corridors
- STBG Apportionment Formula
- STBG Special Rule for Areas Less Than 50,000
- CMAQ Traffic Congestion Performance Measures
- Control of Outdoor Advertising

The following planning issues are addressed by the Federal Highway Administration:

At a minimum, the MPO boundaries shall encompass the entire existing urbanized area (as defined by the Census Bureau) plus the contiguous area expected to become urbanized within a 20-year forecast period for the metropolitan transportation plan, per <u>23 CFR 450.312(a)(1)</u>. Therefore, it is most likely that the MPO would need to include the entire adjusted urbanized area.

The determination to adjust an urban area boundary is a State and local decision that should be made cooperatively between State and local officials and MPOs if the boundary is located within an MPO's MPA. Urban area boundary adjustments are subject to approval by the Secretary of Transportation, per <u>23 U.S.C. 101(a)(35)</u> and <u>23 U.S.C. 101(a)(36)</u>, but <u>FHWA Order</u> <u>M1100.1A</u> delegates the approval authority to the FHWA Division Administrator.

Federal regulations <u>23 U.S.C. 101(a)(35)</u> and <u>23 U.S.C. 101(a)(36)</u> allow States and local officials to adjust urban and urbanized area boundaries; however, there is no Federal requirement for them to make these adjustments or to recalculate the population numbers if they chose to adjust the boundaries. If an urban area is within an MPO's MPA, local officials coordinate with their MPO and State DOT on the boundary adjustment, per <u>23 CFR 470.103</u>. States, MPOs, and local

governments may choose to make boundary adjustments for a variety of reasons, including, but not limited to:

- Aligning urban area boundaries with existing planning boundaries (e.g., MPA boundaries, local municipal boundaries)
- Addressing irregularities in urban area boundary shapes
- Maintaining consistency with highway functional classifications
- Including transit routes and/or traffic generators
- Incorporating local knowledge of urban form (e.g., current and future land use)
- Fostering an inclusive, effective, and comprehensive transportation planning process


Federal funding that the ACOG MPO receives is tied to the urban area definition by the Census Bureau and not the adjusted urbanized area. Staff has the urban area as defined by the Census Bureau (Map 1) and has developed a preliminary adjusted urbanized area map (Map 2). The Technical Committee is asked to review this adjusted urbanized map and make suggestions to the modifications.

Staff will bring this item back before this committee in September for action.


