# SMALL BUSINESS EXPANSION & JOB CREATION



#### A STATEWIDE REVOLVING LOAN FUND

**HB 4064 (Wallace)** is a proposed Statewide Revolving Loan Fund (RLF) to be administered by each of the 11 statewide Oklahoma Councils of Government.

The Oklahoma Small Business Expansion and Jobs Act will utilize a one-time appropriation of \$16.6M to create 11 separate \$1.3M RLFs that are designed to support their regions.

This proposed RLF program will:

- Target small businesses of 50 employees or less to provide low-interest loans and gap financing
- COGs will collaborate with local financial institutions to provide key loans to local, small businesses that support community efforts and spur economic growth
- The proposed legislation also names the Oklahoma Center for the Advancement of Science and Technology (OCAST) as the reporting and administration agency where each COG will submit quarterly loan reports



# SUSTAIN STATE GROCERY SALES TAX

#### SUSTAIN STATE GROCERY SALES TAX



#### TAX RELIEF

ACOG is in favor of a fair and reasonable taxation policy.

Our municipal member governments are highly concerned that removal of the state sales tax on groceries will precipitate a political initiative to eliminate the municipal sales tax on groceries, as well.

This is why we are in opposition to SB 2033 (Deevers).

#### Remember:

- Cities in Oklahoma are predominately dependent on sales tax revenue for operations
- Oklahoma is the only state in the US that does not allow municipalities access to ad valorum tax revenues, which places our cities at a distinctive economic disadvantage in comparison to municipalities in other states

ACOG is requesting a comprehensive approach to legislative tax reform and relief by addressing all potential revenue components, including the sales, income, and ad valorum tax structure for the state.

# MUNICIPAL SANITARY SEWER STANDARDS & LITIGATION



#### ENCOURAGING MUNICIPALITIES TO MAINTAIN & UPGRADE SEWAGE TREATMENT SYSTEMS

The purpose of HB 3049 (Boles) & SB 1650 (Paxton) is to establish reasonable and achievable standards for municipal sanitary sewer system operation that can also protect municipal revenues from nuisance claim litigation attacks. These bills are strongly supported by the Oklahoma Municipal Assurance Group (OMAG).

Multiple municipalities in the ACOG region and across the state have battled million-dollar personal injury damage claims of annoyance and inconvenience in court.

This proposed legislation would:

- Ensure that there would be no right of recovery for a personal injury from a sanitary sewer overflow if the owner/operator of the municipal sanitary sewer system is working to maintain its sewage system in accordance with the guidelines and criteria set forth by the Oklahoma Water Resources Board (OWRB)
- Outlines the 9 components municipal sewer systems must operate by to be protected from litigation



# SUPPORTING RURAL FIRE DEPARTMENTS

#### SUPPORTING RURAL FIRE DEPARTMENTS



#### **VOLUNTEER FIREFIGHTER RETIREMENT**

ACOG supports **SB 1524** (**Green**) which would allow retired volunteer firefighters to continue volunteering without incurring certain reductions in their benefits and bars those individuals from serving as a fire chief.

#### **CONTROLLED BURNS**

**SB1526** (**Green**) adjusts the processes for conducting controlled burns in consultation with the Forestry Division and shields agents of the division from liability exposure when combating fires or overseeing controlled burns.

#### FIGHTING CHANCE FOR FIREFIGHTERS

ACOG supports **HB 3573** (**Pae**) that creates the Fighting Chance for Firefighters Act. It requires a plan offered by the Employees Group Insurance Division of OMES to provide coverage for annual comprehensive cancer screenings for lung, prostate, testicular, skin, colon, and breast cancer.

#### SUPPORTING RURAL FIRE DEPARTMENTS



#### **VOLUNTEER FIREFIGHTER INSURANCE POOL**

ACOG supports **SB 1333** (Hall) which transfers the Volunteer Firefighter Group Insurance Pool into the OMES Comprehensive Professional Risk Management Program.

#### **INTEROPERABLE RADIOS**

ACOG supports carryover legislation SB 966 (Coleman) which provides a revolving loan fund for an interoperable radio system that can be used by all state departments and public safety officials.



# ENHANCING TAX REVENUE COLLECTION

#### ENHANCING TAX REVENUE COLLECTION



#### SALE FOR RESALE

ACOG supports **SB 2025** (**Rader**) which would give the Oklahoma Tax Commission the authorization to revoke or suspend a sales tax permit based on reporting activity. **This would improve the use of the sales for resale sales tax exemption and increase the efficiency of tax collection for municipalities.**

#### COMMONSENSE REGULATORY REFORM



#### **COMMONSENSE TEST FOR LEGISLATION:**

For decades local governments have fought a losing battle to prevent unfunded mandates that both the state and federal governments frequently enact.

Last session, HB 2786 (Munson) and SB 495 (McCortney) were filed stating that the Legislature, state agency, department, or commission shall not implement any mandate to any political subdivision of this State, unless a specific appropriation is made to fully fund the political subdivision for all costs related to the mandate.

ACOG strongly supports this carryover legislation thus creating a commonsense litmus test for all future legislative activity.

#### MENTAL HEALTH -HOMELESS ISSUE



#### MENTAL HEALTH FUNDING

ACOG advocates for increased state funding in mental healthcare, hospitals, and staffing to specifically address the homeless issue. This augmentation in mental health funding would not only enhance the well-being of individuals but also prove advantageous for municipalities statewide.

The growing population of unhoused individuals has imposed a strain on municipal resources, both in terms of funding and staffing.

The mental health and homelessness issue has several moving parts. In 2023, **HB 2175** was signed into law to create the Behavior Health Workforce Development Fund – to allow for the expansion of the number of psychiatric residences. Additional steps are required to address this broad topic.

HB 3338 (Roe) has filed the Oklahoma Mental Health Reform Act of 2024. We look forward monitoring this shell bill as it evolves.

#### TRANSPORTATION SAFETY & FUNDING



#### PEDESTRIAN SAFETY

ACOG supports carryover legislation HB 2752 (Miller) and pre-filed SB 1923 (Alvord) which would modify certain actions for pedestrians, as it pertains to safety. It also adds some language to clarify how a vehicle should pass around a roundabout (central island of a circular intersection).

#### SPEED LIMITS

ACOG is opposed to **HB 3894** (**Ford**) that requires a minimum speed limit of 65 mph on an interstate or turnpike. These minimum speeds are too high and at times may create a dangerous driving environment.

#### COUNTY IMPROVEMENTS FOR ROADS AND BRIDGES

ACOG supports **SB 1421** (**Rogers**) which modifies the apportionment of fees, taxes and penalties collected or received to the County Improvements for Roads and Bridges Act.

#### ROAD USER CHARGE PROGRAM

ACOG opposes **HB 2970 (Gann)** which would repeal the Oklahoma Road User Charge Program.

# ECONOMIC DEVELOPMENT RESTRUCTURING (ODOC)



Over the past few years, the Oklahoma Department of Commerce (ODOC) has had issues in fulfilling its role as the coordinating state agency for economic development. Numerous bills have been filed to change or restructure ODOC or to replace it with an entirely new agency.

#### **ODOC MISSION**

HB 3252 (Osburn) modifies the statement of needs and mission statement of the Oklahoma Department of Commerce (ODOC)

#### **OK to RELOCATE**

**SB 1335 (Garvin)** creates the OK to Relocate Act which forms the OK to Relocate RLF for ODOC and requires the agency to establish a talent attraction program for the purpose of attracting out-of-state businesses to Oklahoma

# ECONOMIC DEVELOPMENT RESTRUCTURING (ODOC)



#### CREATING OKLAHOMA'S MODERN PLAN FOR ECONOMIC TRANSFORMATION & EFFECTIVENESS

**SB 1447 (Thompson, Kristen)** creates the Oklahoma Office of Economic Development, Growth, and Expansion to serve as the state's lead economic development agency with ODOC playing a supporting role.

ACOG will closely monitor these bills but our word of caution to our legislators is that several of our most important programs are funded through ODOC:

- REAP
- Sub-state Planning
- State Energy Program (SEP)

So, whether you simply re-arrange the furniture or tear down the house and build a new one please be aware of the impact that any changes will have in the administration of the vital programs.



### WATER RESOURCES

#### WATER RESOURCES



A variety of water-related bills have been introduced for the upcoming session, however, there needs to be greater focus on long-term drought relief. Even though ACOG does support some of the new bills, the proposed legislation does not effectively address this important issue. The availability of water becomes progressively more pronounced with each succeeding drought cycle and more challenging to resolve.

ACOG supports a more aggressive water resource planning effort both regionally and state-wide which will require extensive coordination with the Oklahoma Water Resources Board and increased funding from the Legislature.

#### DROUGHT COMMITTEE REALIGNMENT - SUPPORT

HB 3182 (PATZKOWSKY) requires the emergency drought committee to meet at the call of the Secretary of Oklahoma Department of Agriculture, Food and Forestry when the Secretary declares that emergency drought conditions exist in the state.

#### WATER INFRASTRUCTURE - SUPPORT

HB 3854 (CORNWELL) would set up a fund for small municipalities and their water infrastructure.





#### APPROPRIATIONS REQUESTS



#### RURAL ECONOMIC ACTION PLAN (REAP)

REAP provides grants to small communities, towns, counties, and other organizations serving populations under 7,000 that have little or no funding capabilities.

There are currently 538 municipalities in Oklahoma under 7,000 in population (90% of all Oklahoma municipalities).

REAP grants can be used to fund capital improvements for infrastructure and public facilities, road and street construction and equipment for health and public safety.

In FY 2024 the REAP allocation was \$30 million, funded over 460 projects across the state and was also used to leverage almost \$50 million in funding for Community & Economic Development projects in rural communities.

FY 2025 Recommendation: Increase REAP funding by \$14 million, which by statute will distribute equal REAP allocations of \$4 million to all 11 Oklahoma Councils of Government (COGs). Fiscal Impact: \$14 million above current allocation of \$30 million.

Please note that ACOG will monitor SB 2033 (Howard), which increases REAP funding but also includes a Revolving Loan Fund (RLF) for loans to REAP eligible communities.

#### APPROPRIATIONS REQUESTS



#### RURAL FIRE DEFENSE PROGRAM

The Rural Fire Defense (RFD) Program supports and equips rural fire departments in protecting lives and property of rural Oklahomans. The Oklahoma Department of Agriculture, Food and Forestry (ODAFF) contracts through Oklahoma Association of Regional Councils (OARC) for the COGs to employ RFD Coordinators who annually certify approximately 875 fire departments across Oklahoma for state operational funding and assist rural fire departments with training, grant writing, inventory and equipment support.

State funding for the RFD program was increased for FY 2024 per COG to \$100,000, which made a huge impact to the program.

FY 2025 Recommendation: Make the current \$100,000 per all 11 Oklahoma COGs a line item in the State budget through the Oklahoma Department of Agriculture and oppose any and all changes that may be proposed to the RFD Program.

Fiscal Impact: Maintain current allocation of \$1,100,00.

#### APPROPRIATIONS REQUESTS



#### SUBSTATE PLANNING DISTRICT PROGRAM

The Substate Planning District Program allows Oklahoma's 11 designated Substate Planning Districts (COGs) to provide planning and technical assistance to local governments. Oklahoma COGs are the primary resource for many local governments to apply for federal and state grants, coordinate efforts to develop capacity to attract business investments and job creation and make the delivery of governmental services more effective.

Substate funding has declined from \$50,000 to its current level of \$13,400 for FY 2024. Maintaining adequate Substate funding is necessary for COGs to continue to provide essential intergovernmental services to local governments in their Districts.

FY 2025 Recommendation: Increase Substate planning funding to \$50,000 per all 11 Oklahoma COGs and make it a line-item in the State budget through the Oklahoma Department of Commerce.

Fiscal Impact: \$402,600 above current allocation of \$147,400.
