 Oklahoma Department of Transportation (ODOT) 8-Year Construction Work Plan Presentation: John Sharp, Deputy Director, and Daniel Nguyen, ODOT Project Management Division Manager.

Jason Boomer, Oklahoma Department of Transportation Project Manager gave a presentation on ODOT's 8-year Construction Work Plan. The work plan continues to focus on reducing the number of structurally deficient bridges in the state, while also focusing on improving pavement conditions statewide and reducing the number of two-lane highways with deficient shoulders. #### **ODOT Transportation Alternatives (TA) Program**

John Sharp said ODOT will open their call for projects for their Transportation Alternatives Program, on January 30. They have \$34 million to allocate statewide. Mr. Sharp said in the case of the ACOG area all communities outside of the blue line on the MPO map can apply for a project. All communities under 15,000 can apply if they are located inside the blue.

ACOG will do another round of TAP funding this fall.

#### Regional Safety Action Plan

In January, ACOG held the kick-off for Regional Safety Action Plan, which is being managed by Kimley Horn. ACOG had a full Board Room of attendees, and several people attended the meeting virtually. There will be a Regional Safety Summit on February 28, 2024, at the Oklahoma Downtown Library. All Policy Committee members will receive an invitation.

#### Climate Pollution Reduction Grant (CPRG)

ACOG has started work with Stantec, the consultant that ACOG hired to work on the Climate Pollution Reduction Grant. They are analyzing the proposed projects that ACOG has received from communities. The type of projects that will be submitted for the Oklahoma City MSA are due to Environmental Protection Agency (EPA) by February 1, 2024. Stantec is 60 percent of the way through the development of the report that must be generated for the EPA. There will be a virtual stakeholder meeting on Tuesday afternoon, January 30.

#### Route 66

There is new Route 66 funding for revitalization and restoration for communities located along the route. This program is run by the Oklahoma Department of Commerce and the deadline February 2, 2024. There is \$6.6 million in funding available. A second round of funding will be available this fall.

#### **INFORMATION:**

ACOG staff will soon be preparing the CY 2023 Network Monitoring Report, as called for by the Unified Planning Work Program. The purpose of this report is to maintain current information on the implementation of multimodal transportation improvements in the ACOG MPO area in conformance with the goals of the Metropolitan Transportation Plan, as well as to update the transportation model. The report will identify all projects completed in 2023 resulting in increased transportation choices, improved traffic flow, and/or increased street/highway network capacities in the region. This information will also be used for crash analyses to determine the relationship between network improvements and crash rates.

Your assistance is requested in identifying all transportation projects within your jurisdiction that were complete/implemented during calendar year 2023, regardless of the source of funding or party responsible for construction. A representative of each entity (see attached list) will be emailed a survey (Excel file) and asked to provide information about roadway, transit, and bicycle/pedestrian improvements completed within their jurisdiction during the past year.

Please return completed surveys to ACOG by Friday, March 1, 2024. As noted in the survey, in the event there were no applicable projects completed in your entity during 2023, a response to that effect would be appreciated as well. Please email completed surveys to TPS Grants at tpsgrants@acogok.org.

A completed survey or a response stating no applicable projects were completed is required to apply for all transportation grant programs.

#### **INFORMATION:**

On August 1, 2023, the Association of Central Oklahoma Governments (ACOG) issued its FY 2024 Public Fleet CLEAN AIR Grants Call for Projects.

Congestion Mitigation and Air Quality (CMAQ) funds and Carbon Reduction Program (CRP) assigned to the ACOG MPO area provide the resources for these competitive grant awards. Eligible projects include fleet conversion to clean fuel technologies, the acquisition of alternative fuel or hybrid vehicles, and/or the purchase and installation of alternative fuel vehicle refueling or recharging infrastructure.

Eligible entities include: ACOG MPO local government member entities, member public transit fleets, public trusts and public authorities that provide essential services to member entities, public colleges and universities, Oklahoma Career Tech System Technology Centers, public school districts, and Public-Private Partnerships (PPPs). For example, private sector entities that contract services such as refuse hauling or school transportation or the establishment of alternative fueling station operations and maintenance to eligible area public entities.

Only the incremental cost of a vehicle's alternative fuel system can be considered for funding under CMAQ guidelines. Federal cost share cannot be more than 80 percent of the total project cost, which includes the vehicle base price plus the cost of incremental alternative fuel system, and any fueling or charging infrastructure. The grant defrays either the incremental cost of an alternative fuel vehicle and/or up to 80 percent of the cost of fueling and charging infrastructure equipment.

Nine (9) applications totaling \$4,286,415.00 were received by ACOG for consideration of the \$4,355,362.00 in CMAQ funds and CRP funds. The following projects (refer to next page) are recommended for award and are projected to reduce criteria pollutants by 478 lbs. annually. Oklahoma County's project was the only project of the nine submitted to be adjusted to a manageable scope, down from \$947,050. This kept the projects under the funding cap. The remaining \$68,947.00 in available funding will be rolled into the next grant cycle.

#### **ACTION REQUESTED:**

Motion to approve the nine projects listed on the next page for funding (\$4,286,415.00), utilizing CMAQ funds allocated to ACOG's Public Fleet Conversion Grant (CLEAN AIR Grants) Program, and move the remaining funds (\$68,947.00) to the next round of ACOG Public Fleet Conversion Grant (CLEAN AIR Grants) Program.

#### **INFORMATION:**

Performance-based planning and programming has become a national emphasis per recent federal transportation legislation—namely, the 2012 Moving Ahead for Progress in the 21st Century (MAP-21) Act, 2015 Fixing America's Surface Transportation (FAST) Act, and 2021 Infrastructure Investment and Jobs Act (IIJA). Federal planning requirements direct metropolitan planning organizations (MPOs) to coordinate with their respective state department of transportation and area public transportation providers in developing 14 performance measures and targets to track and maximize the benefits of transportation planning decisions and infrastructure investments.

Recently, the Oklahoma Department of Transportation (ODOT) submitted the five required safety targets to FHWA. ACOG, as an MPO, needs to identify and submit the regional safety targets for those same five performance measures. Federal guidance states that MPOs may either support the targets of the state or may submit their own targets based on the data from the region. In either instance, ACOG will need to report on the measures and the targets, and eventually explain how the region is making progress towards reaching those targets. This occurs through both the short-range plan (TIP) and Metropolitan Transportation Plan (MTP). In particular, projects should be selected using criteria which help support the goals, measures and targets established by our region in the MTP.

The presentation at the February meeting will review possible options for the regional safety targets and the attachment provided summarizes these options and ACOG's recommendations.

#### **INFORMATION:**

ACOG and the City of Oklahoma City are requesting an amendment to the FY 2024 Unified Planning Work Program (UPWP) budget to utilize FTA Section 5303 - Metropolitan Transportation Planning funds apportioned to the ACOG MPO.

Oklahoma City is requesting an additional \$400,000 in FTA Section 5303 funds, for a total of \$600,000, to complete the MAPS 4 Transit Planned Growth – Long Range Plan, an update of the 2005 Fixed Guideway Study (see letter of request). The FY 2024 UPWP currently includes \$200,000 in FTA Section 5303 funds for this task (see initial letter of request). The proposed costs for the project exceed the prior budgeted amount, and the increase in funding will allow for the development of a more extensive regional study, which will include the three metro area transit agencies: Embark, Norman Transit, and Citylink.

The FTA Section 5303 Program provides funding and procedural requirements for multimodal transportation planning in metropolitan areas that is cooperative, continuous, and comprehensive, resulting in long-range plans and short-range programs of transportation investment priorities. Eligible activities for this funding include the development of transportation plans and programs, technical studies related to public transportation, and the planning, design, and evaluation of public transportation projects. Any future transit routes development through the MAPS 4 Transit Planned Growth – Long Range Plan will be incorporated into ACOG's next Metropolitan Transportation Plan (MTP), assisting ACOG with transportation planning efforts within Central Oklahoma.

FTA Section 5303 is an 80 percent federal funding program, with Oklahoma City providing the 20 percent match.

The proposed budget revisions are reflected in the attached table.
