MINUTES

A. CALL TO ORDER

Chairperson John M. Sharp called the meeting to order at 10:02 a.m. He introduced himself and entertained introductions of members, staff, and guests. There was a quorum.

B. APPROVAL OF THE MARCH 14, 2024 MINUTES

Harry Fenton moved to approve the March 14, 2024 minutes. Nikkiey Morton seconded the motion. The motion carried unanimously.

C. ACTION ITEMS

 FFY 2026 and FFY 2027 Surface Transportation Block Grant - Urbanized Area (STBG-UZA) Project Selections

Jennifer Sebesta highlighted the information as detailed in the agenda memorandum. She referred to the two tables with the FFY 2026 and FFY 2027 STBG-UZA recommended projects. Jaclyn Todd asked why the inflation percent jumped from 3 percent in FFY 2026 to 6 percent in FFY 2027. Ms. Sebesta noted that ACOG works with ODOT to develop an inflation factor on projects for the life of the TIP, as required by federal regulation.

Harry Fenton moved to recommend that the ACOG MPO Policy Committee approve funding for the FFY 2026 and FFY 2027 STBG-UZA Recommended Project Award Lists. David Riesland seconded the motion. The motion carried unanimously.

2. Preliminary FY 2025 Unified Planning Work Program (UPWP) for the ACOG MPO Area

Jennifer Sebesta said this UPWP document outlines tasks proposed for FY 2025 and is completed yearly in order to receive funding. In FY 2025, ACOG will be completing the Regional Safety Action Plan, which was started in FY 2024. The Regional Congestion Management Policy Update will be kicked off with a consultant in the summer or early fall. She said ACOG will be working on the 2050 Plan, which will also require a consultant. Finally, ACOG will have its quadrennial FHWA MPO Certification Review this fall. Ms. Sebesta said the full FY 2025 UPWP document will be brought to this committee in June.

Harry Fenton moved to recommend that the ACOG MPO Policy Committee approve the Preliminary FY 2025 UPWP and transmit to FHWA and FTA for review and comment. David Riesland seconded the motion. The motion carried unanimously.

D. ITEMS FOR INFORMATION ONLY

1. 2024 Ozone Season Preview

Eric Pollard said that last year the region violated the ozone standard and for the first time since he has been here (year 10), we went over for ozone on the three-year average, whereby if EPA would designate today, the region would be out of attainment for the ozone standard. He said ACOG has been coordinating with ODEQ and had a meeting recently to discuss what the timeline is for EPA to designate. ODEQ staff seems to think they will be using 2024-2026 data for the three-year average when they do designate. The next cycle begins in 2025, so they think it will be completed in 2026, but do not know for sure.

Mr. Pollard said EPA is considering tightening the particulate matter (PM)_{2.5} standard, so ACOG has been consulting with ODEQ on that as well. There is a monitor in Oklahoma City, located on I-44 at Will Rogers Park and that could possibly cause a violation if the standard is tightened, as proposed.

He said this causes urgency to get funding for emissions reduction projects and thanked committee members for their help in putting together the Climate Pollution Reduction Grant (CPRG) application which was submitted on April 1, as well as the CMAQ projects in helping to reduce emissions around the region.

Harry Fenton asked for a definition of the $PM_{2.5}$. Mr. Pollard said it is a fine particle pollution generated by vehicle exhaust, burning of various fuels, industrial processes, fires, etc.

Jaclyn Todd noted that the region does not qualify for the FTA Congestion Relief Program due to the 2020 Census population. If they would change the threshold, that could help with carpooling and on-demand programs.

Nikkiey Morton asked if there was some type of resolution that they could take to their higher boards or elected officials so they might be able to have an ozone day that they can declare. Mr. Pollard said yes, in the memo, EPA has an Air Quality Awareness Week whereby there can be postings. Mr. Sharp said on ozone alert days that cities could service their vehicles that day and put off grass cutting. Mr. Pollard said he does not know what the statute is for the counties, but no brush burning on an Ozone Alert Day would be helpful. Mr. Pollard told Ms. Morton that ACOG could come up with a resolution.

2. Federal Functional Classification System Updates for the ACOG MPO Area

Jennifer Sebesta highlighted the information as detailed in the agenda memorandum, encouraging the committee members to begin thinking about potential functional classification system network changes now, as it takes time for review and will not be ready by the time of the next Call for Projects. A resolution is not needed; just update the map, when it is available, and give justification as to why they want it changed. Mr. Sharp said if anyone needs help in this process, to please contact ACOG staff.

3. 2024 Bike Month

Hannah Nolen noted that the month of May is Bike Month and highlighted the information as detailed in the agenda memorandum. Ms. Nolen said flyers are available for the Ride to Work Day events and so far, the cities involved are Oklahoma City, Edmond, Norman, Piedmont, and Yukon. She said all the materials are available on the Bike Month web page and posters are available at the table in the ACOG lobby. Ms. Nolen said Midwest City and Del City are planning rides with children and said if cities have other bike events, to let ACOG know so the events can be added to the calendar and promoted on social media.

4. Grant Opportunities

Hannah Nolen noted the grant opportunities listed in the agenda memorandum. She said if they know of any other grant opportunities, to please tell ACOG staff.

5. Proposed Highway Number Redesignation by the Oklahoma Department of Transportation (ODOT)

Jennifer Sebesta said ODOT has requested approval from FHWA to redesignate existing highways in the Oklahoma City metropolitan area. She referred to the map attached to the agenda memorandum and noted that no highways are being added or removed from the State Highway System at this time. Mr. Sharp said that this is not necessarily a local clarification as much as a national clarification for truckers and other folks traveling through the region.

6. Preparation of CY 2023 Network Monitoring Report

Lauren Wood highlighted the information as detailed in the agenda memorandum, requesting that the communities turn in their network monitoring surveys by May 1. Chair Sharp thanked those who had already turned in their survey.

7. Projects in the ACOG MPO Transportation Management Area (TMA)

John Sharp said there would not be a quarterly discussion today, and looks like it will be in May. He said if they have questions about their projects, please ask ODOT staff, as they are here today.

E. NEW BUSINESS

Chairperson Sharp asked if there was any new business to present.

Request for Change in Due Date for Call for Projects

Brandon Bundy said he would like for the Call for Projects to be moved two months earlier (from October), the reason being that having this meeting to award the projects is so late in their budget cycle. Chair Sharp said yes, ACOG has been trying to do that, so the next Call for Projects will be in July or August. He said this time, ACOG will not change the Criteria or Procedures much in order to move the process forward. ODOT wants to get the money obligated faster, so suggested that the applications include accurate, detailed engineering information so that it can also be paid for.

Extra Pot of Money Coming this Fall

Chair Sharp said ACOG has been told that we will be getting an extra \$10 million of STBG funds this fall, due to receiving back money that was borrowed from ACOG's apportioned funds - like a payback. This money will be for projects that can be completed quickly - safety or maintenance-oriented projects at 80 percent and projects that have accelerated NEPA. He said if they have projects in those categories, to start thinking about using this funding. He also suggested that the project might include a combination of cities whereby they submit an overlay on a shared section line road.

Safety Summit

Hannah Nolen said that next Wednesday is ODOT's annual Safety Summit at the Reed Center in Midwest City.

No further new business was presented.

F. ADJOURN

There being no further business, Mr. Sharp adjourned the meeting at 10:38 a.m.

INFORMATION:

The following amendments have been proposed for the FFY 2024-2027 ACOG MPO Transportation Improvement Program (TIP):

The Central Oklahoma Transportation and Parking Authority (COTPA) has submitted a request to amend the FFY 2024 Transit Element of the FFY 2024-2027 ACOG MPO TIP. COTPA is requesting the amendment (see letter on next page) in order to program FTA Section 5337 State of Good Repair funds (FFY 2022 and FFY 2024) and Ferry Boat Program funds (FFY 2021 through FFY 2024). The funds will be used for the First Americans Museum landing construction.

The second amendment is to replace the FFY 2026 and FFY 2027 local government Surface Transportation Block Grant - Urbanized Area (STBG-UZA) projects with the updated project lists (<u>Table 1</u> & <u>Table 2</u>). The FFY 2026 and FFY 2027 projects selected for funding were approved by the ACOG MPO Policy Committee at its April 25, 2024, meeting.

The third request is to amend FFY 2024 local government projects to include the Air Quality Small Grant projects (Table 3) approved for funding at the November 16, 2023, ACOG MPO Policy Committee Meeting and the Public Fleet Grant projects (Table 4) approved for funding at the February 29, 2024, ACOG MPO Policy Committee Meeting. The Air Quality Small Grant projects will utilize Carbon Reduction Program (CRP) funding apportioned to the ACOG MPO and the Public Fleet Grant projects will utilize a combination of CRP and Congestion Mitigation and Air Quality (CMAQ) Improvement Program funding provided to the ACOG MPO by the Oklahoma Department of Transportation (ODOT).

These amendments ensure consistency among the TIP, Statewide Transportation Improvement Program (STIP), and the grant awards. Upon approval of the ACOG MPO Policy Committee, the request will be forwarded to the Oklahoma Department of Transportation (ODOT) and then to the Federal Highway Administration (FHWA)/Federal Transit Administration (FTA) for final approval.

ACTION REQUESTED:

Consider recommending that the ACOG MPO Policy Committee amend the FFY 2024-2027 Transportation Improvement Program by updating the COTPA FFY 2024 Transit Element with the attached program of projects, replacing the FFY 2026 and FFY 2027 local government Surface Transportation Block Grant - Urbanized Area (STBG-UZA) projects with the updated project lists, and amending the FFY 2024 local government projects to include the Air Quality Small Grant and Public Fleet Grant projects, and submitting the same to the Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP).

INFORMATION:

ACOG staff is currently in the process of developing 2020 base data for the 2050 Metropolitan Transportation Plan (MTP). The MPO is required to develop a Plan update by the fall of 2026. The early work involves assembling land use and socioeconomic data for the base year (2020). This will be followed by utilizing scenario planning to allocate population and employment based on future development patterns and land use capacity.

At this time, the preliminary 2020 total population of 1,333,280 has been calculated at the regional, county, city, and traffic analysis zone (TAZ) level using block level data from the 2020 Census. The TMA boundary has changed since the last plan and so some additional portions of counties and cities have been added. The attached table lists the county and city population totals for 2010 and 2020, and for the 2020 TMA portions. The TAZ data can be viewed online. Click here to view the map and data. ACOG anticipates requesting approval of the data at the June ACOG MPO Technical and Policy Committee meetings.
