# MINUTES

---

## A. CALL TO ORDER

Chairperson Brian Grider called the meeting to order at 1:30 p.m. A quorum was present. He welcomed all in attendance.

## B. APPROVAL OF THE MARCH 28, 2024 MINUTES

Councilmember Peter Hoffman moved to approve the March 28, 2024, minutes. Councilmember Tim Rudek seconded the motion. The motion carried unanimously.

Councilmember Peter Hoffman moved to approve that all items under the Consent Docket be considered in one vote. Councilmember David Bennett seconded the motion. The motion carried unanimously.

## D. REGULAR AGENDA ITEMS THAT MAY REQUIRE ACOG MPO POLICY COMMITTEE ACTION

1. FFY 2026 and FFY 2027 Surface Transportation Block Grant – Urbanized Area (STBG-UZA) Project Selections: Jennifer Sebesta, TPS Division Manager

Jennifer Sebesta highlighted the information provided in the agenda memorandum to the committee. Ms. Sebesta said the ACOG MPO Technical Committee has recommended approval.

Commissioner Mark Sharpton made a motion to approve funding for the FFY 2026 and FFY 2027 STBG-UZA Recommended Project Award List. Mayor Terry Arps seconded the motion. The motion carried unanimously.

2. Preliminary FY 2025 Unified Planning Work Program (UPWP) for the ACOG MPO Area: Jennifer Sebesta, TPS Division Manager

Jennifer Sebesta said this UPWP document outlines tasks proposed for FY 2025 and is completed yearly to receive funding. In FY 2025, ACOG will be completing the Regional Safety Action Plan, which was started in FY 2024. The Regional Congestion Management Policy Update will be kicked off with a consultant in the summer or early fall. She said ACOG will be working on the 2050 Metropolitan Transportation Plan, which will also require a consultant. Finally, ACOG will have its quadrennial FHWA MPO Certification Review this fall. Ms. Sebesta said the full FY 2025 UPWP document will be brought to this committee in June.

Councilmember David Bennett made a motion to approve the Preliminary FY 2025 UPWP and transmit it to FHWA and FTA for review and comment. Vice-Mayor Vickie Douglas seconded the motion. The motion carried unanimously.

3. 2024 Ozone Season Preview: Eric Pollard, Air Quality & Clean Cities Manager

Eric Pollard said that last year the region violated the ozone standard and for the first time since he has been here (year 10), we went over for ozone on the three-year average, whereby if EPA would designate today, the region would be out of attainment for the ozone standard. He said ACOG has been coordinating with ODEQ and had a meeting recently to discuss what the timeline is for EPA to designate. ODEQ staff seems to think they will be using 2024-2026 data for the three-year average when they do designate. The next cycle begins in 2025, so they think it will be completed in 2026, but do not know for sure.

Mr. Pollard said EPA is considering tightening the particulate matter (PM)<sub>2.5</sub> standard, so ACOG has been consulting with ODEQ on that as well. There is a monitor in Oklahoma City, located on I-44 at Will Rogers Park and that could possibly be in violation if the standard is tightened, as proposed.

He said this causes urgency to get funding for emissions reduction projects and thanked committee members for their help in putting together the Climate Pollution Reduction Grant (CPRG) application, which was submitted on April 1, as well as the Congestion Mitigation & Air Quality (CMAQ) projects, in helping to reduce emissions around the region.

4. Proposed Highway Number Redesignation by the Oklahoma Department of Transportation (ODOT): Jennifer Sebesta, TPS Division Manager

Jennifer Sebesta said ODOT has requested approval from FHWA to redesignate existing highways in the Oklahoma City metropolitan area. She referred to the map attached to the agenda memorandum and noted that no highways are being added or removed from the State Highway System at this time. Sam Coldiron, ODOT Geospatial Data Management Division Manager, provided additional information and answered committee member questions.

5. Transportation News and Update Report: John Sharp, Deputy Director

**Bike Month**

Mr. Sharp said May is Bike Month and there are several events planned throughout the region. There is a listing of the events on ACOG's website. ACOG is planning for the annual Bike Fest event on May 5 at the Wheeler Ferris along the river. Bike to Work Day and other bike-related events will be hosted by several of our communities.

**Regional Air Quality Plan**

ACOG is continuing to coordinate with Reagan Smith on the Regional Air Quality Plan. This plan is anticipated to be completed this summer.

**Oklahoma Department of Environmental Quality**

Mr. Sharp said at the beginning of the month, the Oklahoma Department of Environmental Quality held a kickoff meeting to discuss the upcoming ozone season. ACOG will continue to educate and provide Ozone Alerts to residents of Central Oklahoma.

**Regional Safety Action Plan**

ACOG is meeting with Kimley Horn to discuss regional safety issues. They are the consultants working on the Regional Safety Action Plan. This plan will be completed by the end of the year.

**Safety Oklahoma Summit**

ACOG staff attended the safety summit this month in Midwest City. There were over 350 engineers, planners, consultants, law enforcement, and others that attended the event. The summit had many great sessions, including some safety plan presentations by INCOG and ACOG staff.

**Sustainability**

ACOG staff attended the Edmond Sustainability Plan kickoff.

**Budget**

ACOG is in the middle of developing budgets for FY 2025 and coordinating with several federal, state, and local entities.

**Consent Docket**

Mr. Sharp encouraged the committee to check out the Consent Docket because ACOG is now including a grant memo to keep you informed of timely grants that are available.

**INFORMATION:**

The following amendments have been proposed for the FFY 2024-2027 ACOG MPO Transportation Improvement Program (TIP):

The Central Oklahoma Transportation and Parking Authority (COTPA) has submitted a request to amend the FFY 2024 Transit Element of the FFY 2024-2027 ACOG MPO TIP. COTPA is requesting the amendment (see letter on next page) in order to program FTA Section 5337 State of Good Repair funds (FFY 2022 and FFY 2024) and Ferry Boat Program funds (FFY 2021 through FFY 2024). The funds will be used for the First Americans Museum landing construction.

The second amendment is to replace the FFY 2026 and FFY 2027 local government Surface Transportation Block Grant - Urbanized Area (STBG-UZA) projects with the updated project lists ([Table 1](#) & [Table 2](#)). The FFY 2026 and FFY 2027 projects selected for funding were approved by the ACOG MPO Policy Committee at its April 25, 2024, meeting.

The third request is to amend FFY 2024 local government projects to include the Air Quality Small Grant projects ([Table 3](#)) approved for funding at the November 16, 2023, ACOG MPO Policy Committee Meeting and the Public Fleet Grant projects ([Table 4](#)) approved for funding at the February 29, 2024, ACOG MPO Policy Committee Meeting. The Air Quality Small Grant projects will utilize Carbon Reduction Program (CRP) funding apportioned to the ACOG MPO and the Public Fleet Grant projects will utilize a combination of CRP and Congestion Mitigation and Air Quality (CMAQ) Improvement Program funding provided to the ACOG MPO by the Oklahoma Department of Transportation (ODOT).

These amendments ensure consistency among the TIP, Statewide Transportation Improvement Program (STIP), and the grant awards.

**Prior to action by the ACOG MPO Policy Committee, a public hearing will be opened, and comments received from any public in attendance.**

The ACOG MPO Technical Committee has recommended approval. Upon approval of the ACOG MPO Policy Committee, the request will be forwarded to the Oklahoma Department of Transportation (ODOT) and then to the Federal Highway Administration (FHWA)/Federal Transit Administration (FTA) for final approval.

**INFORMATION:**

ACOG staff is currently in the process of developing 2020 base data for the 2050 Metropolitan Transportation Plan (MTP). The MPO is required to develop a Plan update by the fall of 2026. The early work involves assembling land use and socioeconomic data for the base year (2020). This will be followed by utilizing scenario planning to allocate population and employment based on future development patterns and land use capacity.

At this time, the preliminary 2020 total population of 1,333,280 has been calculated at the regional, county, city, and traffic analysis zone (TAZ) level using block level data from the 2020 Census. The TMA boundary has changed since the last plan and so some additional portions of counties and cities have been added. The attached table lists the county and city population totals for 2010 and 2020, and for the 2020 TMA portions. The TAZ data can be viewed online.
